- 1) Accepted the Waiver/forgoing of the right to receive the final dividend of Re. 0.10/- (Ten paise Only) per equity shares @ 10 % at par value of Re. 1/- each fully paid-up for the financial year 2022-2023, which received from Promoter(s) and Promoter group(s) for holding of 18,36,70,000 Fully paid up Equity shares of the company, as informed in the prescribed form pursuant to dividend policy formulated for the purpose of enabling the members/shareholders to waive/forgo the dividend, whether interim or final, to be declared by the Shareholders of the Company.
- 2) Appointment of Lt General Jai Singh Nain (Retd) (DIN: 10289738) as an "Additional Director" in the category of "Non-Executive Independent" of the Company, on the recommendation of Nomination and Remuneration Committee, with effect from 28th August, 2023 to hold office up to the ensuing general meeting, subject to necessary approvals of the Shareholders of the Company.
 - In accordance to the verification made by the Company and its Nomination and Remuneration Committee (NRC), the aforesaid Director is not debarred from holding of office of Directors pursuant to any order of Securities Exchange Board of India (Brief Profile Attached). - 3) In supersession to the intimation made by the Company on 04th August, 202<mark>3 under the subject Outcome of Board Meeting, due to unavoidable circumstances, the Board approved the postponement of AGM of the Company.</mark>
 - Accordingly, 41st Annual General Meeting of the Company which was scheduled to be held on Tuesday, 05th September, 2023 is being re-scheduled on **Tuesday, 26th September, 2023 at 01.00 P.M** through Video conferencing ("VC") and other Audio Visual Means ('OAVM') in accordance with the



relevant circulars issued by the Ministry of Corporate Affairs ("MCA") to transact the business as contained in the notice convening the AGM dated 28th August, 2023. The Remote e-voting period will commence from Saturday, 23rd September, 2023 at 09.00 A.M. to Monday, 25th September, 2023 at 05.00 P.M.

- 4) Approved the revised Notice of the 41st Annual General Meeting ("AGM") of the Company, Directors' Report (Boards' Report), Management Discussion and Analysis Report (MDAR) and other related documents forming the part of Annual Report for Financial Year 2022-2023.
- Pursuant to postponement of AGM of the Company, accordingly, Closure of Register of Members and Register of share transfer books of the Company shall remain closed from "Tuesday, 19th September, 2023 to Tuesday, 26th September, 2023" (both days inclusive), pursuant to Section 91 of the Companies Act, 2013 and Regulation 42 of SEBI (LODR) Regulations, 2015, for the purpose of ensuing 41st AGM and determining the members eligible to receive the final dividend, if approved by the members in the ensuing AGM.
