# Goa, Mumbai share honours

## Evenly poised after the first leg, teams will clash for the decider on March 8 for the place in final

FC Goa faced off against Mumbai City FC in the semi-finals of the Hero Indian Super League (ISL) and were held to a 2-2 draw in the first leg.

Without the services of Ivan Gonzalez and Alberto Noguera due to suspension, Head Coach Juan Ferrando chose to bring back Seriton Fernandes and Jorge Ortiz to the starting lineup, with both players keen to make an impact.

Once the action began, it was FC Goa who started the brighter of the two, with Savitour Gama looking lively down the left and even forcing an early save from Mumbai City custodian Amrinder Singh within the first five minutes.

That early pressure was telling, and just over ten minutes later Alexander Romario went down in the box following a challenge by Vignesh Dakshinamurthy, but the referee waved play on.

It made little difference however as the Gaurs did win a penalty just minutes after, as Jorge Ortiz was brought down by Mandar Rao Dessai.

Igor Angulo stepped up for Goa and calmly slotted the ball home to give his side a vital advantage in the first leg of the two-legged tie.

The goal sparked Mumbai into life, and following a brilliant save from Dheeraj Singh from a Bartholomew Ogbembe strike, the Islanders equalised thanks to Hugo Boumous.

The former Gaur reacted quickest after the ball fell to his feet, and he smashed the ball into the bottom corner to make it 1-1.

That excitement hardly lasted a minute however as Mourrada Fall came back to haunt the Men in Orange as he got on the end of an Ahmed Jahouh cross to nod home the equaliser and make it 2-2.

The second leg of this semi-final will be played on 8 March.

# Athletics coach Snesarev found dead

India's middle and long distance coach **Nikolai Snesarev** of Belarus was found dead in his hotel room at the National Institute of Sports in Patiala, according to the Athletics Federation of India.

The body of the 72-year-old Snesarev, who returned to India after a gap of two years was to be at the helm till the end of September, has been sent to a government hospital for post mortem.

AFI is deeply shocked to learn about the sudden demise of recently appointed middle-long distance coach, Nikolai Snesarev, in Patiala said Adille J Sumariwalla, the AFI president while talking to FPJ on Friday evening.

And went on to add, "He had come to NIS for the Indian Grand Prix 3 (from his Bengaluru base) held on Friday. But when he did not turn up for the meet, the coaches checked for him in the evening and his room was found locked from inside."

"When the door was broken, he was found lying on

his bed. The Sports Authority of India doctor at the NIS declared him dead and the ED (team) of the SAI has referred the body to the government hospital for post mortem.

"We don't know the cause of death. We will know it later after post mortem, added Sumariwalla."

It was last year, the Sports Authority of India (SAI) had approved the appointment of Belarusian Snesarev as the middle and long distance coach of the Indian athletics team, little less than two years after he quit the post.

Nikolai had quit as Indian athletics' long and middle distance coach in February 2019 after Sable opted to leave

him and train under Army coach Amrinder Kumar. His contract then was till the end of the now-postponed Tokyo Olympics.

"Nikolai has had a good record with India and years of experience with our middle and long distance runners. He has helped athletes like Lalita Babar who finished in top 10 in steeplechase at 2016 Olympics. He has good results with Sudha Singh as well as Avinash Sable who trained with him initially," Sumariwalla said.

Nikolai has been associated with Indian athletics since his first engagement in 2005 and has coached a number of other international medal-winning athletes.

# Sindhu books place in last 4

Olympic silver medalist PV Sindhu advanced to the semi-finals of the Swiss Open Super 300 tournament with a straight game win over Thai Bussanan Ongbarn-rungphan but it turned out to be a dismal day for other Indian shuttlers here on Friday.

World champion Sindhu took a minute less than an hour to see off a fighting Bussanan, seeded fifth, 21-16 23-21 to set up a clash with fourth seed Denmark's fourth seed Mia Blichfeldt.

However, it was a bad day in office for other Indians in

fray as none of them could reach the last four.

Olympic hopeful B Sai Pra- neeth, who reached the final in the last edition, lost 14-21 17-21 to Malaysia's Lee Zii Jia in 45 minutes to bow out of the tournament.

Ajay Jayaram's campaign ended after a demoralising 9-21 6-21 loss to eighth seeded Thai Kunlavut Vitid-sarn in another last eight men's singles match.

Earlier, Satwiksai Raj Rankireddy and Ashwini Ponnappa fought hard before going down 17-21 21-16 8-21 to fifth seeds Tan Kian Meng and Lai Pei Jing of Malaysia in quarterfinals of mixed doubles competition.

# Wrestler Sarita Mor to fight for gold

Asian Championship gold medalist **Sarita Mor** assured herself of at least a silver by reaching the women's 57kg final while India's Greco Roman wrestlers Neeraj and Naveen bagged bronze medals in the UWW Ranking Series event, Matteo Pellicone, here on Friday.

The 25-year-old Sarita, who won 59kg gold in Asian Championship in Delhi last year, won both her bouts in domi-

nant fashion. She first outplayed Kazakhstan's Alty-nay Satygan 4-1 in the quarterfinals and then followed it up with a victory by fall against Emma Tissinava, also a Kazakh.

Sarita will now fight for gold against Brazil's Giullia Rodrigues, who prevented an all-India final by defeating Anshu Malik 10-7 in the other semifinal.

Talented Anshu Malik, who is making a transition from junior to senior level and also won a bronze in senior Asian championship in Delhi, scored a confi-

dent 11-6 win over Evelina Georgieva Nikolova from Bulgaria in the quarterfinals before losing to Giullia.

The 19-year-old is now up against Italy's Francesca Indelicato in the bronze play-off.

In the 63kg, Nisha lost the chance to be in the medal round after losing her repechage contest 2-3 to America's Alexandria Junis Claude. 2018 Asian Games medalist Divya Kakran is not competing since she had lost the trials.

Kiran lost her 76kg quarterfinal to Elmira Syzdykova 3-10 to bow out of competition.

Much was expected from seasoned Greco Roman wrestler Harpreet Singh but he bowed out in the 82kg category, suffering a shock defeat by fall against Salih Aydin from Turkey.


However, both Naveen and Neeraj grabbed their chances to fight up the Greco Roman camp.

Neeraj won bronze in the 63kg with a close 6-4 win over American Samuel Lee Jones, while Naveen bagged bronze in 130kg after scoring the last point in a 1-1 tie against Czech Republic's Stepan David.

In 72kg, Kuldeep Malik will also fight bronze against Russia's Chingiz Labazanov. He lost his bout 0-5 to Robert Attila Fritsch from Hungary.

Sunil Kumar (87kg) and Deepanshu (97kg) could not reach the medal round in their respective categories.

# Neeraj Chopra shatters record

Olympic-bound star javelin thrower **Neeraj Chopra** smashed his own national record with a throw of 88.07m, which is also the best of the year so far, in a sensational return to action during the third Indian Grand Prix meet here on Friday.

Competing for the first time in more than a year after the COVID-19 pandemic wiped out the whole of 2020 calendar, Chopra hurled the spear to a distance of 88.07m in his fifth attempt to obliterate his earlier national record of 83.06m, sealed during the gold-winning effort at the 2018 Asian Games.

The 24-year-old Chopra opened the competition with an effort of 83.03m before having two foul throws. After a fourth throw of 83.66m, Chopra sent the javelin to 88.07m amid loud cheers from a sizeable audience at the NIS Patiala. His final throw was 82.24m.

"I was prepared and today it was windy. I used my favourite javelin which helped me. Pandemic did affect training and preparation but we managed to hold on," said Chopra who is also the 2018 Commonwealth Games gold medalist.

"On the world level I would need to perform even better as current standard in the world is quite high."

# Athletic to clash with Barca in final

Athletic Bilbao will have a chance to win two Copa del Rey titles in a two-week span next month.

The Basque Country club reached this season's final on Thursday by defeating Levante 2-1 in extra time, setting up an April 17 final against Barcelona, which advanced past Sevilla on Wednesday.

First, on April 3, Athletic will face Basque rival Real Sociedad in last season's final, which was postponed because of the coronavirus pandemic.

Alex Berenguer scored the winner seven minutes into the second half of extra time to eliminate Levante, which was trying to reach its first

Copa final. The teams drew 1-1 in regulation, repeating the score from the first leg in Bilbao.

This season's final will feature the two most successful Copa clubs. Barcelona is looking for a record 31st title, while Athletic will try to lift the trophy for the 24th time.

Athletic beat Barcelona in the 2015 final for its last Copa title. Barcelona won the tournament for the last time in 2018.

Levante had not reached the semifinals since 1935. Both teams missed chances to score a winner in regulation, and Berenguer decided the game with a shot from outside the area that deflected off a defender and hit the post before going into the net.
