Records phenomenal sales of 938 electric two-wheelers in June'21

Registers the sale of more than 1800 units in the first quarter of FY'22

Vadodara, 05 July, 2021: Despite the unprecedented challenges due to the second wave of COVID-19, WardWizard Innovations and Mobility Ltd *(BSE Code: 538970)* – one of the leading manufacturers of electric two-wheelers brand 'Joy e-bike' closed the month of June 2021 with a positive sales momentum.
